Entry Requirements: Entrants must be licensed cosmetologists (Make-Up artists and clothing stylists excluded) and professional products must have been used in preparation for the photo shoot. Entries require **five (5) unedited images and five (5) "Final"** high-resolution (at least 300DPI) JPG images, no more than 8MB each. Salon Team entries require this completed form AND the NAHA photo release form located on page two of this document to be uploaded online.
